4	Matters raised by attending public. – NM wished to discuss agenda item 8d Resurfacing of the Bayley field, so this was brought forwards. On 15/1/25 NM met with DB, Barry Bolton and Alex Silverwood who is an agronomist. Since the instalment of the ground source heating pipes, there have been issues with the drainage of the field. This may be because old drainage pipes were damaged, or due to the inversion of the clay soil to the surface. Installing new drainage could be complicated by the presence of the heat pump at 1 m depth. AS is going to get an expert to generate a report on the drainage and he will do one on the surface and re seeding. Village Hall committee is funding the report and NM will share the reports with the PC. Timescale, costs and a project plan have been requested, and next steps will be determined with this information in hand.

8c) CCTV -Discussion around was this really necessary or a reaction to recent events in the village. Benefits would be evidence/documentation of incidents. Chipping have found it useful but have a paid manager at the village hall who takes responsibility. Issues for us are around finding people to take responsibility for running it and governance around the correct usage. We would need a policy. Clerk to find out what policies are already available from RVBC **8d)** as above.

Review of risk assessments. Reminder to be done February, May, August, November.

- Footpaths The area between the 1st and 2nd kissing gates on the Tolkien trail around the back of St Peters club is very muddy and impassable. Probably outside the remit of our £500 budget for pathway maintenance, which is more for strimming and pruning. Chair will take a photograph and send it to the footpath department to see if they can improve it.
- Parking. One of the councillors sent a photograph or cars, double parked on the bend at the Shireburn, to the local police station at Longridge and was told that despite number plates being visible they had to be present to ticket in person, but they did not attend, simply said let us know if it happens again. The email trail will be forwarded to Cllr Alan Schofield.

Speeding People are speeding up the Avenue at 8am. Although national speed limit applies after the gateposts, to drive this fast is somewhat unadvisable due to there being no footpaths and a large number of pedestrians. Clerk to write to headmaster to please remind parents.

There was a query about people speeding through the village around St John's. The police have advised that there is nowhere suitable to park a mobile speed unit in this area to assess.

12 AOB:

Grit bins: were discussed but the day after the meeting bins on The Dene, Bilsbury cottages and approaching St Johns had all been filled and repaired/replaced as necessary.

Absent councillor: The parish council is quorate and functional in covering for an absence and is happy to continue doing so.

Bus stops: BKV judges thought they needed sprucing up. Councillors felt that they were in good repair. The little library has been a success, thanks to Fran Wemyss Holden, and the bus shelter is clean and tidy.

Post and chain fencing around the cenotaph/club. Is likely to need repair and replacement in the not too distant future and should be considered for the forward plan. Add to agenda for next time.

Chaigley road: Now two sets of traffic lights, wall still not repaired after 6 months. Clerk to forward correspondence from Highways to Cllr Schofield.

Puchbowl: hearing scheduled at the high court at the end of February.

Bayley Arms: Simon Tipton is leading a community interest group.
